2/1-b) Proposal towards construction of "Canoe Jetty" at Muxer with 3mts. wide channel 200 MTR. length and 1mts depth "in V.P. Panchawadi Ponda Gsa. for which Sarpanch told Gramsabha that this requires NDE from land owners & their are obstacles & debris which need to be removed so also there is a "band" which also need to be removed, Panchayat to process the proposal after obtaining requirements towards proposal.

e) Jeronno Costa questioned about the incomplete road (internal road) from fedel house to Benit house on which Sarpanch told Gramsabha members that the said road estimate is done by P.W.D. & will be taken up by P.W.D. Roads, further decided to put reminder letter to P.W.D. Roads towards completion of said road.

f) Details as regards to incomplete work of narrow bridge (Sakav) at muxer and at maten panchawadi on which Sarpanch told Gramsabha that the GSR of said (Sakav) has been changed & send for revised estimates by P.W.D. Roads. further after completing the legal formalities P.W.D. will take up the said works.

2/2: Application of Ashton Rodrigues Amblai Panchawadi placed before the meeting as below:

2/2-a) Ashton Rodrigues raised a issue of water scarcity & water crises in Panchawadi village, Gram Sabha members explained how people within Panchawadi village are striving for water, Sarpanch explained that panchayat had already made correspondence to regulate water supply to only Panchawadi village from Maisal Dam if water level is low. And send letters to WRD minister and water supply department Gram Sabha proposes following remedies to overcome the water crises in future.

\* Proposal towards Disilting of Maisal Dam for which will result in stocking of more water.

- \* Verifying the water availability before giving any NOE's towards water supply. Specially to Mega Project will will deplete the water level.
- \* Installation of valves at various places within in V.P. Panchawadi Jurisdiction so as to control water supply when water pipeline burst.
- \* Water regulation/supply report from P.W.D. Water Supply as how much water supplied for how many hours a day to Village Panchawadi
- \* There should not be water diversion when it is water scarcity.
- \* Accordingly it is decided to submit above proposal to concern department and P.W.D. water supply & W.R.D. to resolve the water crises. and the resolution is passed Unanimously.
